Evernote is a free app that can be downloaded to multiple devices through the iTunes app store. It allows the user to create, save, annotate, search and share notes. Notes are synched with shared devices. Notes can include text, photos, reminders, attachments, and audio notes. You are able to search both typed and handwritten notes. Notes can be shared via Air Drop, text, email, Google Drive and social media. There is a full compliment of editing tools.

This App can be used across the disciplines and grade levels. Teachers can create and share documents with students.
